



## **CLUB POLICIES AND RULES**

Violation of any of these rules or conduct in a manner prejudicial to the best interests of the Club will subject the person in violation to disciplinary action by the Club in accordance with these Rules and Regulations.

In no event shall the Club discriminate against any individual because of the individual's race, color, religion, sex, national origin, age, handicap or marital status.

Complaints or suggestions concerning the management, service or operation of the Club should be in writing, signed by the member and addressed to the Club Operations Manager. Errors in billing charges should be directed to the attention of the Accounting Department.

### **HOURS OF OPERATION**

The Club Facilities shall be open on the days and during the hours as may be established by the Club. Areas of the Club may also be closed for scheduled maintenance and repairs. Certain areas of the Club may be designated as "member only" facilities.

Use of the Club Facilities may be restricted or reserved from time to time by the Club.

Facility Availability will change dependent on appropriate climate, conditions and safety for usage. This can include, but is not limited to: daylight savings, temperature, forecasted weather, etc. Please check in with the pro shop or offices with any questions or concerns regarding the availability of the club on a given day.

### **CLUB EMPLOYEE CORRESPONDENCE**

Members should not request special personal services from employees of the Club who are on duty or the personal use of the Club's furnishings or equipment which are not ordinarily available for use by members.

Members and their guests may not abuse any of the Club's employees, verbally or otherwise. All service employees of the Club are under the supervision of the Club Manager, and no member or guest shall reprimand or discipline any employee, nor shall a member request an employee to leave the Club Facilities for any reason. Any employee not rendering courteous and prompt service should be reported to the management of the Club immediately.

## **CLUB FACILITY USAGE**

Any performance by entertainers may be permitted on the Club Facilities only with the permission of the Club.

Commercial advertisements shall not be posted or circulated in the Club nor shall solicitations of any kind be made on the Club Facilities or upon the Club's stationery without the prior approval of the Club. Other than as permitted in writing by the Club, no petition shall be originated, solicited, circulated or posted on Club property.

Members shall not use the roster or list of members of the Club for solicitation or commercial purposes or distribute the roster to anyone other than a member.

It is contrary to the Club's policy to have its facilities used for functions or fundraising efforts for the benefit of a political cause, except as specifically permitted by the Club. The Club Facilities shall not be used in connection with organized religious services or other activities except as may be approved by the Club.

The use of the facilities by children (under 16) will be determined by the Club. The Club requires that children under 16 be accompanied by an adult member while on Club property.

Members are responsible for the conduct and safety of their children when enjoying the Club Facilities.

## **CLUB RESTRICTIONS**

Dogs or other pets (with the exception of those assisting persons with disabilities) are not permitted on the Club Facilities, except with the permission of the Club. Where dogs are permitted on the grounds, they must be on a leash. Members are responsible for damage caused by an animal owned by the member or under the member's control.

Self-parking is permitted in areas identified as such. No parking will be allowed on grassed areas. "No Parking" signs must be observed. Vehicles parked in violation of "No Parking" signs may be towed at the owner's expense.

The Club allows long-term parking for members under the following conditions:

- Vehicle does not exceed 20ft. in length and 10ft. in width.
- Vehicle must operate and travel without assistance. (No towed trailers or campers, etc.)

Smoking is not permitted within 15 feet of the following areas; the restaurant, the pro shop, the sales center, the recreation center, or the pool area. Smoking is permitted on the golf course; however, if dry conditions and fire danger are present, the Club may prohibit smoking on the course as well.

No fireworks are permitted anywhere on Club property or adjacent areas unless part of a fireworks exhibit organized and conducted by the Club.

Firearms and all other weapons of any kind are not permitted on Club property at any time.



## **MEMBER CODE OF CONDUCT**

Members are responsible for their own conduct and for the conduct of their family members and guests. Any member whose conduct or whose family's or guest's conduct shall be deemed by the Club to be likely to endanger the welfare, safety, harmony or good reputation of the Club or its members or is otherwise improper, may be reprimanded, fined, suspended or expelled from the Club and have all privileges associated with the membership suspended or terminated by the Club. The Club shall be the sole judge of what constitutes improper conduct, but improper conduct will include, without limitation: (i) failing to meet eligibility for membership, (ii) submitting false information on the Membership Agreement, (iii) allowing his or her membership card to be used by another person or providing non-members access to member-only amenities, such as tennis courts, recreation center or pool, (iv) failing to pay any amount owed to the Club in a proper and timely manner, (v) failing to abide by the rules and regulations as set forth herein and as established by the Club from time to time, (vi) abusing Club personnel or employees, or (vii) acting in a manner incompatible with the standard of conduct of the existing membership or which would likely injure the reputation of the members or the Club.

Protocol for members who are determined to be in violation of club policy or code of conduct risk immediate indefinite suspension. During the time of the suspension, the Club will investigate all matters and come to a decision regarding any and all disciplinary action. A member may request a hearing with Club management within ten (10) business days of their suspension. A decision will be made after deliberation of club management pertaining the status of the suspended member's privileges or membership at Ironbridge. Any correspondence regarding these matters will be directed at the Club Manager.

The Club may restrict or suspend some or all of a member's, family member's and/or guest's Club privileges. If the Club determines that a member's conduct or the conduct of his or her family or guest is improper, the Club may expel the member, suspend or restrict the member's membership privileges, or restrict the use privileges of the member's family or guest whose conduct was improper. No member is entitled, on account of any restriction or suspension, to any refund of any membership deposit, dues or any other fees. During the restriction or suspension, dues and other charges shall continue to accrue and shall be paid in full prior to reinstatement as a member in good standing. Under no circumstances will a suspended member/membership have any rights or use of the club and its facilities.



## **MEMBER PRIVILEGES AND CLUB ETIQUETTE**

### **GUEST PRIVILEGES**

Guest privileges may be extended under the rules established by the Club from time to time. Although it is the intention of the Club to accommodate guests without inconvenience to the members, the Club reserves the right to limit the number of guests that are invited or are sponsored by a member over the course of a membership year and the number of times a particular guest may use the Club Facilities in any given membership year. The Club shall establish from time to time the rate of the daily guest fees, charges and the rules and regulations for use of the Club Facilities by guests. Guest privileges may be denied, withdrawn or revoked at any time for reasons considered sufficient by the Club, in its sole and absolute discretion.

A member may bring guests to the club and accompany the guests in their use of the club facilities. An accompanied guest on the golf course must be in the same foursome as the member during the guest's entire use of the facilities. A member may also sponsor guests to use the Club Facilities unaccompanied by the member by making arrangements with the Club.

A particular individual using the Club Facilities as a guest must be registered by the sponsoring member with the Club. The Club reserves the right to require identification by each guest. The member will be charged guest fees for their guest's use of the Club Facilities as determined from time to time by the Club.

Guests will be entitled to use the Club Facilities only in accordance with the privileges of the membership of the sponsoring member.

Guest charges for any services can be paid by the guest or be charged against the sponsoring member's club account. Cash payments are permitted.

The sponsoring member shall be responsible for all charges incurred by the guest. The sponsoring member is also responsible for the conduct of a guest while at the Club. If the manner, deportment or appearance of any guest is deemed to be unsatisfactory, the sponsoring member shall, at the request of the Club, cause such guest to leave the premises of the Club.

## **CLUB ACTIVITIES AND EVENTS**

The Club provides a variety of social, cultural and recreational events in which all members are encouraged to participate. Special events and functions may be scheduled from time to time at the discretion of the Club.

The Club encourages the use of Club Facilities by members for private functions. Members are requested to make reservations with the appropriate Club personnel for available dates and arrangements. Private events at the Recreation Center will be scheduled at the Club's discretion, limited to two parties a month, Memorial Day to Labor Day, Monday thru Thursday, no Holidays, after 4 pm. Private parties will not be restricted from October thru April.

Private functions are permitted at the Club only with prior permission of the Club. The individual sponsoring the function shall assume full responsibility for the conduct of guests and the removal of any decor. The sponsor of the function shall be responsible for any damage to the Club Facilities and for the payment of any charges not paid by individuals attending the private function.

## **ATTIRE**

**General Attire** - It is expected that members will choose to dress in a fashion befitting the surroundings and atmosphere provided in the setting of the Club. It is also expected that members will advise their guests of the dress requirements. The Club may publish dress requirements from time to time. Shirts and shoes must be worn at all times when on Club Facilities. Bathing suits may only be worn in the pool areas. All other Club Facilities require appropriate cover-ups.

**Tennis Attire** - Proper tennis attire as determined by the pro shop is required at all times. Colors are permitted. Examples of attire not permitted are: T-shirts with graphic designs, undershirts, fishnet shirts, cut-offs, jams, blue jeans, bathing suits and slacks. Regulation tennis shoes are required.

**Golf Attire** - **proper golf attire is required for all golfers. This includes:**

**Men:** Shirts with collars and sleeves, turtlenecks or mock tees (collar must be a minimum of 1 1/2" in height), slacks, tailored or Bermuda shorts (no greater than 4" above the knee) are considered appropriate attire. Tank tops, tee shirts, mesh shirts, sweat pants, warm-up suits, blue jeans, swim wear, short shorts, cut-offs, gym shorts, tennis outfits or other athletic shorts are not permitted.

**Women:** Dresses, slacks, skirts or shorts (no greater than 4" above the knee) and blouses are considered appropriate attire. Halter tops, tank tops, tee shirts, cut-offs, sweat pants, warm-up suits, blue jeans, swim wear, short shorts, or other athletic shorts are not permitted.

Metal spikes are not allowed at the Club. Shoes with "soft spikes", spike-less shoes, or golf sandals must be worn by all golfers.

This dress code is mandatory for all players. Improperly dressed golfers shall be asked to change before playing. If you are in doubt concerning your attire, please check with the pro shop before starting play.



## **MEMBERSHIP ACCOUNTS**

### **RULES AND REGULATIONS**

#### **PAYMENT METHODS AND BILLING**

Members' dues will be billed on a monthly basis unless otherwise determined by the Club. Resident Members' dues will be paid to the IPOA.

A member is entitled to charge privileges at the Club so long as his or her membership is in good standing and the Member has an active Credit Card on file with the Club. Cash payments may or may not be permitted as determined by the Club from time to time.

Members have the option of having dues, fees and other charges billed (at the time of purchase) to their credit or debit card on file with the Club, or billed directly to their club house account. Such charges will be billed on a monthly basis and members will receive a written statement of their charges via email on the first of the month. Members may choose to have their club house account auto-reconcile to the Credit Card on file on the first of the month or they may pay their bill by cash or check by the tenth of the month. All members agree to pay directly to the Club any amounts not paid by the credit or debit card company within ten days of receipt of written notice from the Club. Any charges not paid by the Member by the tenth of the Month will be billed to the Credit Card on file. Dues only for a Resident Member will be paid by the Ironbridge Property Owners' Association.

Members are responsible for ensuring that the payment information on their file with The Club is up to date. Members are subject to finance charges if their payment method is invalid in any way or cannot fully pay for their member balance or any open invoices on their account. The Club is not responsible for any expired, delinquent or invalid payment methods and are not held accountable for any updates required on a member's account.

The Club may require clubhouse minimums, in its discretion, which the Club may charge to the member's club account if the member does not charge such amount during each period.

## **PAYMENTS AND DELINQUENCIES**

Club accounts shall be deemed delinquent from the date first billed if payment is not received within 10 days after the date of the monthly statement. Past due bills will be subject to a five percent (5%) interest on the overdue balance per month, but not to exceed the maximum amount permitted by law. The late payment charge shall accrue 10 days from the date of the monthly statement until the account is paid in full. Members having past due bills may be charged a reinstatement fee at the discretion of the Club to reactivate an account once it is deemed delinquent.

If a member fails to pay any club account within 10 days of when it is first billed, the Club shall have the right to suspend membership privileges in the Club at any time until the delinquent account is paid in full. Under no circumstances will a suspended member/membership have any rights or use of the club and its facilities. Continued delinquency for a period of 90 days from the date a club account is first billed or repeated incidents of delinquency by a member may result in termination of membership in the Club.

If the club account of any member is delinquent, the Club may at its option take whatever action it deems necessary to effect collection, including without limitation, suspension or termination of a membership or legal action. If the Club commences any legal action to collect any amount owed by any member or to enforce any other liability of any member to the Club, and if judgment is obtained by the Club, the member shall also be liable for all costs and expenses of such legal action and reasonable attorneys' fees, including any fees required in connection with appellate proceedings.

## **HOLIDAY FUND**

It is customary for the Club to send a letter providing an opportunity for members to contribute a suggested contribution to a Holiday Fund for all seasonal Club employees. Payment of such contribution will be voluntary and will be included on the contributing member's November bill. This Holiday Fund provides the members with an opportunity to show their appreciation to seasonal Club employees during the holiday season. Club management shall be responsible for the distribution of these funds.



## PROPERTY AND PERSONAL INJURY

Each member, as a condition of membership and each guest as a condition of invitation to the Club Facilities, assumes sole responsibility for his or her property. The Club shall not be responsible for any loss or damage to any personal property used or stored on the Club Facilities, whether in lockers or elsewhere. Any such personal property which may have been left in or on the facilities for **six (6) months** or more without payment of storage thereon may be sold by the Club, with or without notice, at a public or private sale, or may be otherwise disposed of, and the proceeds, if any, may be retained by the Club.

No person shall remove from the room in which it is placed or from the Club's premises any property or furniture belonging to the Club without proper written authorization.

Every member of the Club shall be liable for any property damage caused by the member, any guest or any family member. The cost of such damage shall be charged to the responsible member's club account.

Any member, family member, guest or other person who, in any manner, makes use of or accepts the use of any apparatus, appliance, facility, privilege or service whatsoever owned, leased or operated by the Club, including without limitation, the use of golf carts, or who engages in any contest, game, function, exercise, competition or other activity operated, organized, arranged or sponsored by the Club, either on or off the Club's premises, shall do so at his or her own risk. The member and his or her family members and guests shall hold Blue Heron Properties, LLC (the Company), any manager of the Club Facilities, their affiliates, their successors and assigns and their respective shareholders, partners, directors, officers, members, employees, representatives, agents and members of the Club's advisory Board of Governors or committees (collectively, the "Indemnified Parties") harmless from any and all loss, cost, claim, injury, damage or liability sustained or incurred by him or her, resulting from the use of the Club Facilities, including without limitation, the wearing of golf shoes with soft spikes or spike-less shoes, or otherwise, arising out of or incident to membership in the Club and/or from any act or omission of any of the Indemnified Parties. Any member shall have, owe and perform the same obligation to the Indemnified Parties hereunder in respect to any such loss, cost, claim, injury, damage or liability sustained or incurred by any guest or family member.

Should any party bound by these Rules and Regulations bring suit against any of the Indemnified Parties in connection with any event operated, organized, arranged or sponsored by the Club or on any other claim or matter in connection with membership in the Club, and fail to obtain judgment therein against any one or more of them, said party shall be liable to the prevailing Indemnified Parties for all costs and expenses incurred by them in the defense of such suit, including court costs and attorneys' fees and expenses through all appellate proceedings.



## **GOLF RULES AND ETIQUETTE**

The Rules of Golf as adopted by the USGA together with the Rules of Etiquette as adopted by the USGA shall be the rules of the Club, except when in conflict with local rules or with any of the rules herein.

Pace of play at Ironbridge Golf Club is 4 hours and 30 minutes (15 min. per hole). It is the responsibility of each group to be observant of its position on the course, to play ready golf and keep pace with the group ahead. If a group falls one hole behind, the Ironbridge Staff will help the group get back into position. If a group falls two holes behind the group ahead, they will be moved back into their correct position and skip a hole if needed. Players unable to keep proper pace may be requested to leave the course. If a player is repeatedly warned for slow play, the Club may take such action as it deems appropriate, including without limitation, restricting the person's use of the golf course during certain times of the day.

For all golfers to enjoy Ironbridge, please follow these Pace of Play suggestions:

- 1) Be observant of your position on the golf course and play **READY GOLF**
- 2) The driver of the golf car drops off the rider at his/her ball then proceeds to their own ball and does not wait for the rider to hit.
- 3) Carry extra clubs and balls if you are being dropped off at your ball
- 4) Park your golf car at the green where you will be exiting for the next hole
- 5) Line up your putt while others are putting
- 6) When a hole is completed, leave the green promptly and record scores on the next tee box

Golfers stopping for more than a grab and go beverage/snack at the turn will lose their position on the golf course and will need permission from the Starter to resume play.

If inclement weather should move into the area, it is at the golfer's discretion to continue or stop play at their own risk.

Each player must have his or her own set of golf clubs.

Jogging, bicycling, or recreational walking is not permitted on golf cart paths at any time.

All beverages must be purchased from the Club. Outside beverages (BYOB) is prohibited.

"Discontinued Play" Policy: less than six holes played - full 18 hole credit.

## **TEE TIMES AND GROUPINGS**

To make a tee time, go to [www.ironbridgeclub.com](http://www.ironbridgeclub.com) or call the golf shop at 970.384.0630

Members may book one month in advance and Guests (public) may book two weeks in advance.

All golfers must register in the golf shop before beginning play. Failure to check in and register ten minutes prior to a reserved starting time may result in assignment of another starting time or cancellation, at the discretion of the starter or golf professional.

Starting times must be made online. Golfers without a starting time may be allowed to play at the discretion of the pro shop. Starting time changes must be approved by the pro shop.

Members should notify the pro shop of any cancellation within 48 hours of their scheduled time to avoid "No Show" charges for unused tee times.

Twosomes and Singles may play at the discretion of the Golf Shop. They first must be paired with another twosome/single before creating a new starting time. Twosomes and Singles may only book tee times 48 hours in advance. Twosomes and Singles should not expect to play through foursomes and should not exert any undue pressure on the groups ahead. Foursomes shall always have the right of way.

"Cutting-in" is not permitted at any time. All players must check in with the starter. Under no circumstances are players permitted to start play from residences.

## **GENERAL GOLF CART RULES**

The use of golf carts is mandatory.

Ironbridge allows the use of private golf cars. These golf cars are stored at the owner's property. Member-owned golf cars must have proof of liability insurance in order to operate on Ironbridge property.

Members and Guests must check-in with the golf shop before using a golf car.

Golf cars may only be used on the golf course when the course is open for play.

Golf car operators **MUST** have a valid Driver's License or Learner's Permit.

Two golfers and two sets of golf clubs are allowed per golf car.

Obey all golf car traffic signs. Always use golf car paths where provided.

Use the 90 degree golf car method when entering and leaving the golf course from the path.

Keep golf cars out of the native grass and penalty areas.

Golfers are liable for any damage done to the golf car.

Violations of the golf car rules may result in loss of golf car privileges and/or playing privileges.

## **PRACTICE AREAS**

Practice is not allowed on the golf course. The practice facilities should be used for all practice.

The practice area is for MEMBERS ONLY. Guests may use the practice area in conjunction with their purchased round of golf.

The practice area opens 30 minutes before the first tee time and closes 1 hour before sunset. The practice area will close early on Monday evenings for a weekly clean pick.

All members must check in at the golf shop before using the practice area. Guests accompanied by a member can use the practice area for a \$25.00 daily fee.

Range balls are for practice area use only and may not be used on the golf course. Furthermore, range balls must be hit from designated areas. No hitting is permitted from the rough or sides of the driving range.

## **HANDICAPS**

The Club will offer the management of any golfer's USGA Handicap for a small, yearly fee. The Club is not, however, responsible for posting past scores or updating an index based on irrelevant scoring. Ironbridge will uphold the USGA standards in regards to handling handicaps and running events.

Club Sponsored tournament scores will automatically be posted on participants' behalf. Double posting scores is strictly prohibited by the USGA. This includes Men's and Ladies' League play.

USGA Handicap Indexes (or any certified handicap provided index) may be required to participate in certain events hosted by The Club.



## **FOOD AND BEVERAGE**

### **RULES AND REGULATIONS**

Dining room activities for groups will be permitted only with the permission of the Club.

Alcoholic beverages will not be served or sold, nor permitted to be consumed, at the Club in any manner prohibited by state or local law. The Club reserves the right, in its sole discretion, to refuse service to a member or guest when that member or guest appears to be intoxicated.

All food and beverages consumed on the Club Facilities must be furnished by the Club unless otherwise permitted.

Employees are permitted to deliver food or alcoholic beverages to locations away from the immediate area of the clubhouse or other designated areas of the Club only with the permission of the Club.

Children under the lawful drinking age are not permitted in any lounge unless accompanied by an adult. Children under the age of 21 shall not be permitted to sit at the bar in the Restaurant.

Alcoholic beverages will not be served or sold, nor permitted to be consumed, at the Recreation Center during hours or at locations prohibited by law. No alcoholic beverages will be sold or served to any person not permitted to purchase the same under the laws of the State of Colorado, or any applicable ordinances or regulations. All alcoholic beverages consumed or otherwise possessed on the Recreation Center facilities must be sold and purchased at The Kitchen at Ironbridge. Persons may not remove alcohol from the Recreation Center facilities. The Club reserves the right, in its sole direction, to refuse service to a member or guest.

### **GRATUITIES**

For the convenience of all members, a gratuity percentage, as determined from time to time by the Club, may be added to all food and beverage sales. A member may increase the gratuity percentage by signing the ticket invoice and changing the amount of the gratuity as the member deems appropriate.



## **RECREATION CENTER**

### **RULES AND REGULATIONS**

Use of the recreation areas at any time are at the members' and guests' own risk. Any injuries or accidents should be reported to the Club staff immediately. Use of the pool, fitness center or athletic facilities may result in certain unforeseeable risks. The Club shall not have any liability to any member, or guest of a member, for damage or injury resulting from use of the recreation facilities. The Club is under no obligation to have a lifeguard or a lifeguard with specific training in the pool facilities

Skateboards, bicycles, roller skates, roller blades, etc., are not permitted on club facility property. Please use roadways and sidewalks as permitted by the HOA.

Members, families and their guests shall abide by all rules and regulations of the Club as they may be amended from time to time.

### **FITNESS CENTER**

The Fitness Center is for members only. Access cards are NON-TRANSFERRABLE.

Members are responsible for knowing their own physical abilities and limitations, as well as proper use and replacement of all equipment.

Please no wet bathing suits or bare feet in the fitness center.

Appropriate gym dress required – this includes clean clothing and athletic shoes.

Children under the age of 16 must be accompanied by a responsible adult of 18 years or older.

For security and safety, this facility is monitored under 24-hour video surveillance.

A \$25 fee will be assessed to replace a lost access card.

## **TENNIS**

The Rules of Tennis of the USTA shall apply at all times, except when in conflict with the local rules or with any of the rules herein.

All Members must sign-in at Pro Shop before using the tennis facilities.

The front desk personnel at the Pool House will make all court reservations Memorial Day thru Labor Day and the pro shop at all other times. Members may make court reservations 72 hours in advance. Players may not "double book" courts on the same day (two court times- different opponents, unless prior approval is obtained from the Club.

Court Times other than peak times are one (1) hour for singles play and 2 hours (2) for doubles play. Playing time may be extended if court is not reserved, however court must be relinquished, upon request, to players that have not utilized a previous court time.

Cancellation of court times must be made 24 hours in advance of scheduled time to avoid a charge.

Proper tennis attire as determined by the Club is required at all times. Cut-offs, Bermuda shorts, jama's, bathing suits, mesh shirts, tank tops, sweat pants, and slacks are not permitted. Required attire includes collared shirts for men and tennis coordinates for women. Regulation tennis shoes are required. All guests are expected to adhere to the dress code.

Proper tennis etiquette should be observed at all times. Excessive noise, racquet throwing or profanity will not be permitted at any time.

Use of the tennis courts shall at all times be subject to the control of the Club. The Club may close or reserve courts for special events or maintenance when needed.

The Club staff may implement temporary rules during peak play periods as deemed necessary.

Courts are restricted to 4 people per playing surface and must include at least one member.

## POOL

The Ironbridge Golf Club Pool is a private Members Only area. Members may bring guests to the pool for a \$15 per person fee. Guests must be accompanied by members at all times.

The pool is open from 10:00 A.M. to 8:00 P.M. Adult swim is from 10:00 A.M. to 11:00 A.M. during which it is lap swim only on the deep end of the pool.

In the absence of a parent of a member child under 14, the guest fee for the supervising adult may be waived.

All swimmers must shower prior to entering the pool and hot tub.

Children in the hot tub must be accompanied by an adult. There is no rough play allowed in the hot tub.

Only proper swimming attire is permitted in the pool area and cut-offs are prohibited. Parents or guardians may wear street clothes with rubber-soled shoes when they are present to supervise their children.

Bathing suits are not permitted in the Golf Pro Shop or the Clubhouse. All bathers must dry off before entering the Pool. Bathers are required to wear coverups when in the building.

Rafts and other flotation devices may be allowed at the shallow end only and at the pool attendant's discretion. No jumping off the sides of the pool onto flotation devices or kickboards.

Only Alcohol purchased through the Club may be brought onto premises.

Food and gum are not allowed in the pools or hot tub. Food is allowed only in designated areas of the pool facilities.

Bottles, glass objects, drinking glasses and sharp objects are not permitted in the pool area. Trash should be placed in the proper receptacles located throughout the pool area.

The pool may be closed by the pool staff during inclement weather. Pool staff will reopen facility when weather conditions permit. Swimming is permitted only during designated hours.

No running is permitted in the pool area. Diving is not permitted.

Fishing, spear fishing and snorkeling equipment, other than a mask and snorkel, are not to be used in the pool area except as part of an organized course of instruction.

Radios, televisions and the like are permitted only when played using personal headphone devices, as not to disturb other Members.

Persons who leave the pool area for over 30 minutes must relinquish lounges and chairs by removing all towels and personal belongings. Saving chairs for persons absent from the pool area is prohibited.

Children who are in diapers or are not potty-trained must wear swim diapers. There will be no lifeguard on duty in the pool area. A parent **MUST ACCOMPANY** children who use wading pool and/or Water Spray Garden and must keep his/her child in view at all times.

Members and Guests are responsible for any damages to property of the Recreation Center. Recreation Center privileges may be suspended for violation of any of the above policies at the discretion of the Club management.



## **FLY FISHING RULES AND REGULATIONS**

All members must check in with the Fly Fishing director prior to fishing and identify which location they will be fishing at.

The rules as established by the Colorado Division of Wildlife are incorporated herein by reference. Members are required to abide by these rules.

Members must observe all state and local laws concerning river and fishing activities.

A licensed angler does not need to accompany a youth.

Fishing licenses are not transferable.

It is illegal to take any threatened or endangered species.

Proper fishing etiquette should be observed at all times. Remember that your activities may affect other fishermen.

Safety precautions must be observed when fishing. All persons who fish at the Club do so at their own risk. The Club is not responsible for the safety of members and their guests during fishing and river activities.

All members and their guests will respect the property rights of others when fishing the river as there are several areas along the river where neighboring property abuts Ironbridge Club property. These areas are clearly marked with signage and in some cases fencing. In particular, nearby Ironbridge lots 63 thru 69 are areas that have been marked with the appropriate signage.

## **POND FISHING**

Fishing in the golf course lakes, when approved, is for members and guests only.

All fishing on golf course ponds will be catch and release ONLY.

All fishing on golf course ponds require the use of barbless hooks ONLY.

Fish must be released immediately into the same water where it was caught when fishing in golf course ponds.

## **RIVER FISHING**

A fishing license is required for persons 16 years or older who desire to fish at the Club in accordance with Colorado laws and regulations. Fishing licenses are available from the Colorado Division of Wildlife. This only applies to river fishing.

Children under 16 years of age are not required to obtain a fishing license but must observe limits and all other fishing regulations. The bag limit, however, is half the daily bag limit except when the bag and possession limit is one. This only applies to river fishing.

Children under 16 years of age can take the full daily bag and possession limits if they purchase a fishing license. This only applies to river fishing.

Fish caught and placed on a stringer in a container or live well, or not returned to the water immediately, count towards the daily bag or possession limit when fishing the river.

Fish that are released immediately will not count towards the daily bag and possession limit when fishing the river.

## **Event Booking Regulations**

All events must go through Serena at least a month in advance.

Ironbridge Kitchen only accepts reservations for parties of up to 12 people. For parties of 13 or more, Ironbridge requires a buy-out to reserve.

Ironbridge offers a full buy-out for the restaurant as a whole including front and back dining rooms as well as front and back outside patios with a \$5,000 minimum food and beverage charge. A partial buy-out is also available which includes the back dining room and back patio with a \$3,000 minimum food and beverage charge.

Ironbridge does not allow any 3rd party or external food or beverage including catering without Serena's approval.

Without a buy-out, the restaurant will operate as it sees fit regarding seating, music, and general use of the facilities
